1. Topic

This conference aims at exploring all dimensions of governance, given its polysemic, pluri-dimensional and multidisciplinary aspects. Governance will be analyzed under different perspectives: business, economics, public and territorial governance, in relation to performance and added value. The scope of this conference is broad and papers submitted should contribute to the study of governance and its mechanisms in various organizations, institutions or territories through the point of view of performance and value creation.

The international dimension of this conference aims at investigating the various governance models and structures that exist in different countries and organizations, all of those being greatly affected by institutional, economic and social factors, as well as the weight of the different stakeholders.

Contributions are expected to come from researchers as well as professionals in different disciplinary fields and in particular, Management, Economics, Legal, Politics, Sociology, History and Geography, Territorial economy and planning, as well as other social sciences.

2. Thematics

The conference is structured around two thematics: 1) Research focused on governance with respect to the type(s) of Organization and 2) Special themes on governance (see below).

3. Submission requirements

Papers with theoretical as well as empirical approaches will be accepted.

This conference is also intended to be a place for exchanging and brainstorming ideas and projects within the scientific community as well as with professionals coming from organizations and businesses worldwide.

Papers will first be selected based on an extensive summary of your communication proposal that should not exceed 3 pages, be written in a Word format, and be submitted **no later than January 15, 2018.**

The papers selected by our committee of scientists, scholars and experts, will be recommended for publication in a collective book and a special issue of a scientific journal referenced in FNEGE. Authors will be notified by the Committee upon acceptance of their abstract and will have to submit their full paper which shall be between **5000 to 7000 words** to be accepted for publication.

Template for communication proposal – Detailed abstract
(Those requirements will be strictly enforced during the selection process)

1. Author(s) presentation:

The 1st page of the proposal shall include the following information which should be separate from the main body of the abstract.

- Paper title (10 words limit, font 14):
- Last name
- First name
- Institution (Laboratory/University/Enterprise/Organization)
- Professional address
- Email address
- Phone number

3. Abstract (50 words limit) and six key words (in French and English)

4. Paper summary (1200 words):

The 2nd page of the proposal must include the following:

- Research Objectives, main idea and problematic -200 words
- Literature review- 300 words
- Methodology - 200 words
- Results - 300 words
- Findings and outcomes - 200 words
- Bibliography: main references of the paper - 10 to 15 max

4. Template

Authors must strictly follow the following instructions:

- Microsoft Word
- Font: Times New Roman
- Font size: 12 with single spacing
- Orientation: Portrait
- Titles and sub-titles in bold, on a separate line, with left justification and uppercase letters.

5. Communication proposals requirements

- Communication proposal must be written in French **or** in English.
- Only one submission per author.
- At least one author must register and present his paper in person. Registration fees must be paid no later than April 30, 2018, or the paper will be removed from the proceedings.
- All decision regarding the selection of papers are final without the possibility of appeal.

- In the interest of fairness to other participants, selected authors must commit to attend the conference and should inform the committee as soon as possible if they decide to withdraw their paper.
